Liquid Nitrogen Shipping Tank Rental and Hold Harmless Agreement

You agree that when you rent ICSB’s Liquid Nitrogen Shipping Tank (Tank) to transport the frozen semen, you accept and assume all responsibilities for the condition of this frozen semen as well as the safety, security, preservation, and use of this frozen semen. ICSB may not and shall not be held liable or responsible for any damage to this frozen semen.

You acknowledge and agree that ICSB has done all they can in fully charging the Tank to last 7 days if all proper handling of the Tank is followed. You agree that at the time of rental, ICSB has informed you of proper Tank handling. You accept and agree that any mishandling of the Tank by you or any other parties can possibly result in damage to the frozen semen. You agree that ICSB and its owners, employees, and agents will be indemnified and held harmless by you or any other party for the condition in which the frozen semen arrives at their facility.

ICSB has explained how to return the Tank and you have been informed of the date that the Tank is due back and you agree to pay the additional late fees if the Tank is delivered to ICSB after that date. You also agree that after 30 days, if the Tank is not returned to ICSB, ICSB may charge the payment method provided by you for the full price of a new Tank and carrier. You agree that you are also responsible to pay for any damage to the Tank or its carrier. The rental Tank can be picked up from ICSB’s facility or shipped to where you designated.

By your signature below, you authorize ICSB to perform services for you at your own risk. You agree to all the terms and conditions in this agreement preceding your signature below. You agree for ICSB to charge the fee for services to your provided payment method below. You understand that other charges may be applied at a later date, if additional services are necessary and ICSB may or may not notify you of these additional charges prior to charging you. You further state that ICSB has offered to provide an estimate of these charges to you and you agree to any fees ICSB charges without informing you. If you initiate a chargeback, or a check is bounced, you understand you will be charged additional fees. If ICSB has to prove in any way that you authorized the use of your provided payment method below, you will incur additional fees from ICSB any time they are required to prepare a response to your chargeback. You also agree that any person that pays fees billed to your account at ICSB will be guaranteed by you. Any person you ask ICSB to bill on your behalf will be informed by you of fees or charges made by ICSB. If the person reverses any charge at ICSB, you will be held liable for reimbursement to ICSB immediately. It is your responsibility to ensure ICSB is paid for all services performed by or charged through ICSB to your account at ICSB.

Proper LN2 Shipping Tank Handling

1. Tank should be shipped out for no more than two-day shipping when transporting frozen semen.
2. Tank should be placed upright and in a cool environment to maximize length of charge.
3. A general rule to check the charge of the tank is to remove the cap: if vapor rises from the tank, the tank is still charged enough to safely store frozen semen.
4. It is always recommended to fill the tank with liquid nitrogen to constantly charge the tank and be assured of the integrity of the frozen semen.
5. The tank should be completely recharged with liquid nitrogen before transporting the semen.

LN2 Shipping Tank Fees:

One-Week Tank Rental: \$95

(Tank Rental begins the day the Tank is shipped out.)

Late Fee for Each Day After Rental Expires: \$15

Replacement of Liquid Nitrogen Shipping Tank: \$1000

Replacement of Liquid Nitrogen Shipping Tank Carrier: \$400

The cost of shipping out the Tank and the cost of the return label are dependent on the destination.
