## **Frozen Semen Disposal Authorization Form**

When you have decided to give up your frozen semen for the dog below, you may opt to authorize ICSB to dispose of and destroy the frozen semen or you may opt to transfer ownership of the semen to ICSB or donate to AKC Purebred Preservation Bank. The second option is generally selected by semen owners who may want to have the semen back in the future or who may want to keep the semen alive without being responsible for the costs associated with storing the semen or who may want to donate the semen to ICSB for scientific study, research, and development. With the second option, in the future, if the semen is still available and ICSB agrees, you may request a transfer of ownership back to you by paying certain fees to ICSB. The third option is to donate to AKC PPB: we are currently partnering with AKC PPB to conserve breeds for the future by preserving semen that people no longer wish to store, even from dogs with genetic/health issues. This form must be signed and dated by all owners of the frozen semen of the following dog.

You understand and agree that once the ownership of the frozen semen of the above dog is transferred to ICSB, it becomes the property of ICSB, and ICSB has full authority and the legal right to use the semen as ICSB sees fit. This may include, but is not limited to scientific study, research and development, sale, donation, artificial insemination, transfer of ownership to others, transfer of ownership to you with certain fees paid by you, or disposal of the frozen semen. The account on this dog will remain open until this completed form is received by ICSB.
